**President Obama's Senior Advisor Tours  
La Clínica's San Antonio Neighborhood Health Center**

On March 5th, a top confidant to President Obama got a close look at how federal stimulus dollars are being put to use. Senior Presidential Advisor Valerie Jarrett toured La Clínica's San Antonio Neighborhood Health Center with Congresswoman Barbara Lee and Jane García, La Clínica's CEO. The tour was followed by a press conference to highlight federal stimulus funding for Community Health Centers.

Valerie Jarrett praised La Clínica San Antonio, calling it proof positive that the Recovery Act funds are being well-spent:

"In an area where the population is struggling each and every day to make ends meet, and doesn't have insurance, you provide an opportunity for them to have the most important care, whether its helping children with immunizations, whatever the issues are, you guys help them right here," said Valerie Jarrett about La Clínica.

The press conference came to an end with remarks from Lois Watkins, a patient at the San Antonio Neighborhood Health Center. "To us seniors, it's a blessing, La Clínica is a godsend," said Mrs. Watkins. She is a Medi-Cal and Medicaid recipient who has been receiving comprehensive health care at La Clínica since 1985.

## President Barack Obama signs landmark health care reform bill into law!

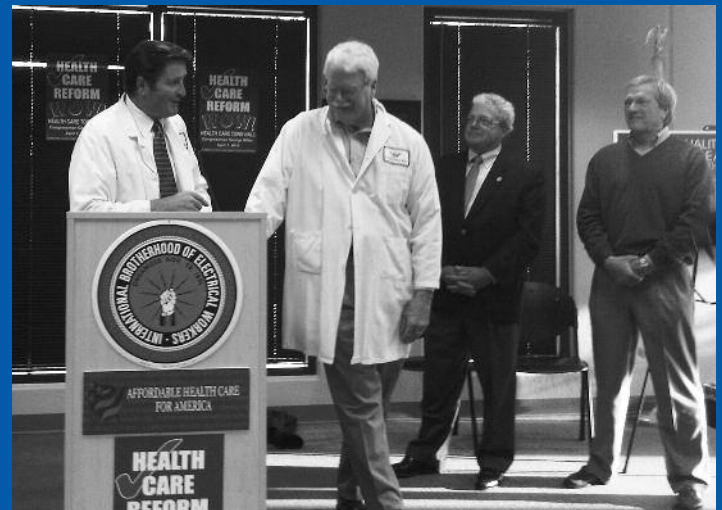
After a year of debate and grassroots advocacy efforts to ensure health care coverage for 32 million Americans, Congress brought a landmark health care reform bill to fruition. “The bill I am signing will set in motion reforms that generations of Americans have fought for and marched for and hungered to see,” said President Barack Obama.

The health care reform legislation appropriates \$11 billion in new funding for community health centers over the next five years, of which \$1 billion will become available in the 2011 fiscal year. As part of the \$11 billion, \$1.5 billion has been appropriated for community health center construction and renovation. Health reform ensures that community health centers continue providing the care that so many in our low income communities need and allows us to invest in equipment, facility expansion and electronic health record convergence. This funding will help us create new sites, stimulate new jobs and renovate existing sites. Ultimately, this will allow us to see more patients.

As a nation, we have taken a giant step towards ensuring that Americans can access affordable and comprehensive health care coverage. La Clínica has witnessed the urgent need for fundamental health reform every single day in the faces of our patients, who for too long were left behind by our broken health care system.

Health reform will prevent Americans from choosing between paying bills or buying their prescriptions. Under new legislation, insurance companies will no longer be able to drop a person’s coverage when they get sick, place lifetime limits or restrictive annual limits on the amount of care a person can receive, and they will no longer be able to deny coverage for pre-existing conditions. As a community health center, we are delighted with the passage of health care reform. This will allow us to expand the health care services available to our current patients and also extend health care to communities that have not had basic primary care services.

As a community health center, we are a viable health care option for many. And as health reform provisions begin to take effect, we will stand ready to continue serving those that need health care most and create an equitable health care system in our communities.

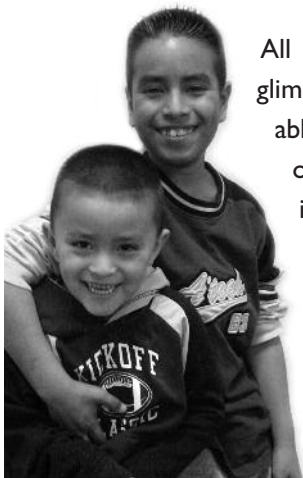

In 2009, La Clínica was able to purchase an INR Machine, which helps patients on blood thinners; a Sigmoidoscope for the diagnosis of gastro-intestinal problems; a system for the storage and usage of liquid nitrogen in our clinics; a jaundice meter to help assist pediatric patients in their first months of life; along with funding critical infrastructure including a new refrigerator for storing vaccines.



All of these projects give just a glimpse of the needs that we are able to meet through the donations of supporters like you. La Clínica is very grateful to be a part of such a strong community committed to the health and well being of their neighbors.
