"America's Health Centers: Making Community Initiative and Enterprise Work" is the theme of Community Health Center Week which is being observed this week.

Community health care centers are recognized for the health services they provide to more than 9 million people living in medically underserved rural and urban communities across the country.

Golden Valley Health Center, which serves the Patterson area, has been a community health center since 1977. The center, located at 200 C St., is one of more than 850 community based centers which provide care through 2400 sites throughout California, the District of Columbia, the Virgin Islands, Puerto Rico, and Guam.

Founded in 1972 as a private nonprofit corporation, Golden

Valley Centers provide primary medical and dental care, lab, Xray, pharmacy, translations, and health education. There are health care centers in Patterson, Westley, Modesto, Turlock Gustine-Newman, Merced, Planada, Le Grand, Dos Palos, and Los Banos. More than 45,000 people on 156,000 visits are

served each year.

### Westside health organization promotes Community Health Center awareness

This is Community Health Center Week, Sept. 16-21, and the Los Banos unit of Golden Valley Health Centers is joining other Golden Valley units to remind area residents of what it is they do in the community.

In addition to Los Banos, Golden Valley has centers in Dos Palos, Gustine, Newman and Patterson on the Westside. Other centers are located in LeGrand, Merced, Modesto, Planada and Turlock.

Michael O. Sullivan, CEO for the group, took the week's recognition as an opportunity to remind area residents of the organization's purpose, to serve medically underserved areas—rural and urban areas with few or no health care providers and with a substantial number of low income and uninsured people.

"The underlying goal of the community health center has been to help communities and their people take responsibility for their health," said Sullivan. "Health centers fill a critical void, providing care for those whom other providers are unable to serve, including low income and uninsured working families."

The administrator said that health centers such as the ones in Los Banos and Dos Palos offer both primary and preventive health services. But he notes that it doesn't stop there. Most health centers also offer health education, provide community outreach, aid with transportation to care and provide translation services, depending upon the particular needs of a community.

"While health center services are not free," Sullivan states, "no one is turned away because of inability to pay. Patients are charged on a sliding fee scale to ensure that income or lack of insurance cov-

erage is not a barrier to care."

Sullivan said that Golden Valley Health Centers make a difference in communities by providing cost-effective, high-quality health care. "Studies demonstrate that total health care costs for health center patients are on average lower than other providers serving the same population," he said.

He also made these points:

- Health centers bring health care providers, services and facilities to communities often not served by others.
- Health centers offer comprehensive one-stop primary and preventive health care.
- The centers are held to strict, uniform national standards.
- Communities are challenged by health centers to meet their local health needs.
- Health centers provide cost-effective prenatal care, reducing adverse effects.
