## First Enrollment Cycle Coming To A Successful Close

Family HealthCare Network expects to work up to the last day of the enrollment deadline of March 31, 2014 for the State's Health Care Marketplace. From October 1, 2013 to March 7, 2014, FHCN has completed 3,511 single applications. Most families have multiple members



included on each application. The team has been completing over 700 single applications a month since December 2013. The organization's goal for the year was 4,000 over a 12-month period and this will likely be reached in 5 months! Congratulations to our Community Health Representatives who have helped so many consumers and patients apply for health care coverage!

### FHCN Will Add A 457(b) Plan To Benefits Lineup

FHCN will be adding a 457(b) plan to its benefits lineup effective May 2014. What is a 457(b) plan? It is a deferred compensation plan (similar to our 403(b) plan), but it is only available to a select group of individuals per IRS guidelines. FHCN's plan will be available to Medi-Cal Billable Providers and the Leadership Team. The intent of adding the plan to our benefits is to be able to provide another means of helping staff save for their retirement, over and above the 403(b) plan. A representative from HR will be sending communication to the eligible employees in the near future regarding next steps.
